1. Call to Order/ Roll Call/ Welcome

The meeting was called to order at 6:00 PM by Mark Henshaw.

2. Citizen Comments

4. Discussion Items

4.a. Updates on the harvesting program to date.

Total Deer Harvested: 111 (77 in first 15 days, 34 in next 20 days)

Deer Donation: 70 donated — 52 for processing, 18 as whole deer

Lost Deer: 8 lost/5 found (net loss 3) in the first period; only 2 lost in the last 20 days.

Harvesters: 26 currently active; 41 approved; 101 have applied; 20 still need to requalify (requalification every 30 days). ~30 pending background checks.

Donation Participation: 19 of 26 active harvesters participated in donation.

Harvest Sites: Operated between 6-8 sites

Equipment Stats: Lost deer disproportionately from crossbows (7/10) versus compound bows (3/10).

4.b. Discuss and review the Wildlife Advisory Committee Mission Statement.

Members reviewed, signed, and submitted the new mission statement.

4.c. Discuss any operational issues that may require committee approval.

- Cooler repair is expected this week.
- Challenges with online test development. Temporary use of printed “A and B” written tests resumed.
- Committee members visited a trap in Ingram; a model adaptable for local use.
- The City must apply for a trap permit (minimum 30-day processing; no fee); the permit would cover any Granite Shoals property.
- The trap can operate year-round if deer are declared a public hazard; otherwise, October—March (aligns with MLDP).
- Purchased trap may be funded by a committee member or Ark of the Highland Lakes, with meat-sharing possible.

- Every 5 donated deer earns a buck tag; process is rollover (e.g., 10 donates earns 2 tags, etc.).
 - 10 logged volunteer sessions (site support, feeder maintenance, processing help) also eligible for a buck tag.
 - Buck tags reserved: 45 total (10 held in reserve for reward/operational needs, 35 allocated for Earn-a-Buck).
 - Extra tags to be requested if needed.
 - Periodic review of criteria—restrictions may be loosened if tags go unused.
